

OFFICIAL CONTEST RULES

1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

2. Eligibility. Oxy-View, Inc's iPod nano. contest (the "Contest") is open to all residents of the United States, 18 years or older at the time of entry. Employees of the Oxy-View, Inc, and their immediate family members of, and any persons domiciled with such employees, are not eligible.

Return of prize notification as undeliverable or no response within 5 days may result in disqualification and an alternate winner may be selected. Winners may waive their right to receive prizes. Prizes are non-assignable and non-transferable. No substitutions allowed, except that prizes and individual components of prize packages are subject to availability and Oxy-View reserves the right to substitute prizes of equal or greater value. If any such provision is determined to be invalid or otherwise unenforceable, these rules shall be construed in accordance with their terms as if the valid or enforceable provision was not contained therein.
